- All other Peli BioThermal products are guaranteed against breakage or defects in workmanship for 90 days from the date of delivery or first use, whichever occurs first.

Compliance with all regulatory requirements regarding labeling, transport, worker safety, training, or hazardous materials including but not limited to radioactive materials, are the sole responsibility of the purchaser or the person offering the contents for transport and not Peli BioThermal. No warranty as to compliance with any such regulatory requirements is intended or implied.
